# KADUNA ANNUAL SEMINAR 2021

he SWIT Annual Seminar for the year 2021 took place on Tuesday, 18th May, 2021 at Hotel Seventeen, No 6, Tafawa Balewa Way/Lafiaya Road in Kaduna State. The theme for this year's annual event was PARADIGM SHIFT IN TAX PRACTICE NARRATIVES DURING THE COVID 19 ERA. The event proper commenced by 10.00am with an opening remarks by Dr. Abiola Adimua, FCTI (2021 SWIT Annual Seminar Chairperson) and Alh. Kamoru Adeleke Ayodele, FCTI (Chairman of Session 2021 SWIT Annual Seminar and a CITN past President). Welcoming address was delivered by Hajia Kudirat Abdul-Hamid, FCTI (The SWIT National Chairperson-as she then was).

The keynote address was delivered virtually by Dr. Ifueko Omoigui-Okaurum FCTI and the Goodwill messages were delivered by the CITN President and Chairman of Council, in person of Dame Gladys Olajumoke Simplice, FCTI (as she then was) and Mrs. Hadiza El-Rufai, the Wife of the Executive Governor of Kaduna State and Mr.

# Theme: PARADIGM SHIFT IN TAX PRACTICE NARRATIVES DURING THE COVID 19 ERA.

Muhammad M. Nami, FCTI; the Executive Chairman. Federal Inland Revenue Service. After the CITN presidential awards and tea break, Dr. Ifueko Omoiaui-Okauru, FCTI, who is best described as a "thinker. strategic leader and change agent" with proven leadership ability at the board and executive management level, presented the paper on the topic, "Impact of Nigerian Tax Policies on the Economy and Small Businesses in Nigeria - the role of Women Professionals" and the discussant was Dr. Zainab Gobir. The discussant, Dr. Zainab Gobir on a background to the paper, said that a paradigm shift in the way business is conducted is taking place as new rules are aligned with tax systems most especially in the current time where Digitization, Globalization and

COVID-19 have become certainty and rules that suit specific circumstances are needed in Nigeria. It now become imperative the Nigerian economy to leverage on its TAX policy. It should be noted that "good tax policy" does not change during times of large budget deficits or healthy surpluses. Good tax systems can fall woefully short of creating adequate revenue during recessions, and poor tax systems can raise plenty of money (but they could be

She further discussed on the following aspects:

- Globalization is a CHILD of a WOMAN: On this, she said, globalization is the process of developing a stage of any organization or community as well as nation and culture. It changes time and again as time passes away. Globalization is a process where world is interconnected and it affects all elements of society. This leads to the disappearing of boundaries which makes it easier to do business with other countries. Globalization is a process of interaction and integration among the people, companies, and governments of different nations, a process driven by international trade and investment and aided by information technology. This process has effects on the environment, on culture, on political systems, on economic development and prosperity, and on human physical well-being in societies around the world.
- 2. Current and Future Solutions for the Current Realities: Difference solution and suggestions that could be adopted to meet and get ahead of the current realities.
- Interesting Initiatives Deployed by other Countries to Control the Rapid Changes: The impact of globalization on corporate income tax is multi-faceted. Of particular interest are issues such as transfer pricing and the impact of taxation on direct investment into a jurisdiction. The increasing mobility of investment capital has brought about pressure on and a degree of meeting of effective and statutory tax rates on corporations across the globe. Other countries have achieved lower effective tax rates by maintaining higher rates and introducing a number of selective tax incentives:
- I Trying to minimize tax
- l Dividend payment is high and improved
- Company choosing where to build their physical location due to tax reliefs being

- offered by countries, states, etc.
- Tax on profit challenges due to digitization.
- 4. New initiatives that could be adopted to mitigate these current realities are Nigeria Tax strategy initiatives.
- Large business publish and update annually their tax strategy.
- Approach to tax planning.
- Risk management and governance to Nigerian tax authority, amongst others.
- 5. How to trace or ascertain Genuity and or triggers for the tax authority.
- How to determine actual motives of the company (financial vs impact)
- Return financial or impact only and mitigate the corporate true intentions.
- Corporate only pays when impact is found this shows that the care for impact.
- Incentive commercial below market rate return.
- Payment ahead result (matrix) comes later (conditional grant vs free grant with no outcome report needed).
- Risk is transferred to risk investor. If project fails to return component if the project is successful return is realized and will increase profit which will increase tax payable.
- Interest on growing the Small Medium Enterprises (SME) and in turn will improve Personal Income Tax, SD, VAT and other levies.
- 6. Progressive taxation enable achieve improved service delivery to the public. A good tax policy needs to satisfy both efficiency and equity criteria. Any tax policy is, however, continually subjected to pressure and changes. The best approach to reforming taxes is one that consider taxation theory, empirical evidence and political and administrative realities and blending these with a good dose of local knowledge and sound appraisal of the prevailing macroeconomic and international situation to produce a feasible set of proposals sufficiently attractive to be implemented and



robust enough to withstand changing times.

7. Global participation on these strategies: Tax strategies can be bland but its left to tax authority to invest time and resources to digest and come up with reports of findings and the growth in revenue, and information for the government as a whole. The tax system has strong powers and guidance on the decisions of investors, investment undertaken, the manner in which such investment is financed and the activities of multinational corporations.

The discussant concluded itemizing the following:

- Ø Tax holidays
- Ø Investment allowances and investment tax credits
- Ø Timing differences, including accelerated depreciation allowances
- Ø General rate reductions
- Ø Export processing zones (in many instances)

And by asking the question, "Does our laws support these initiatives and are we willing to drive this process together? All hands on deck"

### 2<sup>nd</sup> Session

The lead paper at the second session was presented by **Dr. Ruth Abiola Adimula**, **FCTI**, who had and is still holding many capacities and currently the SWIT National Chairperson and the Chairperson Board of Trustees of Women and Child Watch Initiatives (NGO). She spoke on the topic "Strategic Career Development: Tips for the Female Professional". In her paper, she talked about women having good potentials to attain the peak of their careers if the strategies in her presentation are followed. That is,

- ü Attaining competence in their currentjob
- ü Building one's image and reputation
- ü Networking
- ü Developing new skill

- ✓ Developing new opportunities
- ✓ Mentorship

Also, tips for women professionals include:

- ◆ Confidence
- Planning
- Persistence
- Time management
- ◆ Self-promotion
- Handwork & Diligence
- ◆ Be available
- Strong personal branding and reputation
- ◆ Integrity
- ◆ Take on new challenges
- Be focused

She further emphasized importantly that married women should work their trust into their own husbands, whereby she can be supported to work in collaboration with other colleagues for expansion of horizon. Women should be given the opportunity to be available to participate in career opportunity.



Dr. (Mrs.) Caroline Mary Ndubuisi, FCTI one of the discussant on the lead paper-Strategic Career Development Tips for Female Professionals, mentioned that women who are successful and satisfied in their careers often engage in proactive and not reactive planning. Few of the points she discussed on are as follows:

- ✓ Find good mentors and role model.
- ✓ Do the work, volunteer to complete challenging projects and assignments
- ✓ Develop your skills
- ✓ Understand your organization



- ✓ Develop your skills whether through informal training or certification; keep your technical and management skills current and lead about emerging knowledge areas.
- ✓ Understand your culture.
- Develop a strong personal brand and be visible.
- ✓ Build your network both inside and outside of your organization so that you have option if your situation changes.
- ✓ Ask for feedback that is, the only way to improve is to know what to improve on. Feedback will help you meet some expectations and avoid any miscommunication that may jeopardize your prospect for growth.
- ✓ Project confidence: The more confident and competent you appear, the more you will be able to build confidence in your ability and in others.
- ✓ Be persistence, and tech-savvy, those who are more efficient in the use of the internet spend less time surfing the net as they know what to look for.
- Do not dress to please anyone but yourself, dress in a professional manner.

The second discussant, **Dr. Sani Hadiza**, a Consultant Physician/Dermatologist; in her contribution on Career Development Tips for Female Professionals that:

- Develop your skill through training and emerging knowledge.
- Identify organization problems and proffer solutions.
- Plan your career, having goal will not only allow you to track your progress but will allow you make alteration if your circumstances change.
- Find a mentor/role model for guidance, recognition and impress important people.
- Always have a well-organized resume

- to make you competitive.
- Build your network that is building interesting project and impressing important people.
- Be visible and outstanding in your career.
- Be confident, persistent and someone people want to work with.
- Finally and more importantly, be transparent and prayerful.

Dr. Ruth Abiola Adimula obtained her Ph.D in Peace and Development Studies in 2014, LL.M 2004 (Obafemi Awolowo University) and LL.B in 1992 (ABU, Zaria). Her area of research include Law, Gender, Internally Displaced Persons and Refugees in West Africa. She holds a Certificate of Harvard University, USA in Child Protection (2020).

She is a Senior Lecturer at Centre for Peace and Strategic Studies, University of Ilorin, Ilorin, Nigeria; the Principal Partner of Biola Adimula & Co., a firm of Legal Practitioners established since 1995 with head office in Ilorin, Kwara State, Nigeria and the Principal Partner of BAC Tax Consultants in Abuja, Nigeria. She is a Rotary Peace Fellow (Class 23) Chulalongkorn University, Bangkok, Thailand (2017).

Dr. Adimula is a Member of the Chartered Institute of Taxation of Nigeria since 2003 with No. 6477. Until her election, she was the First Vice National Chairperson of Society of Women in Taxation. Dr. Adimula was a Faculty/Guest Lecturer in September, 2020 at the National Institute for Security Studies (NISS), Abuja and an

External Examiner in November, 2020. In February 2018 she was a Faculty Lecturer at the University of the Incarnate Words, San Antonio, Texas. She was also in Murray State University Kentucky and Trinity University Texas, USA as Guest Lecturer (2018). Between April and June, 2021, she served as a member of the Team of Experts- Review Committee and also the Validation team at Martin Luther Agwai International Leadership and Peacekeeping Centre, Jaji, Nigeria, on Piracy in the Gulf (UNDP Project).

Dr. Adimula is the President of Commonwealth Scholars and Fellows Alumni Association, Nigeria (COSFAN) and the Secretary, Board of Trustees of COSFAN; the National Publicity Secretary, Society for Peace Studies and Practice, Nigeria; Peace Ambassador, Institute for Economics and Peace, Sydney(2018) and a Member (Assessor) Association of Commonwealth Universities Grant Selection Panel, London, United Kingdom.

You will agree with me that for the past one and a half year, there has been a dramatic and significant global change in the ways of life, as a result of the



COVID-19 pandemic and other variants thereafter. Our God is faithful for keeping us safe and alive to today. It gives me great pleasure to welcome you all to my investiture which I hold in high esteem as a divine gift and assignment for more impacts.

### **CITN AND SWIT**

Society of Women in Taxation is the women wing of the Chartered Institute of Taxation of Nigeria and thus we are part and parcel of CITN. We appreciate the President and Chairman of Council, past Presidents, Council Members and the entire leadership of CITN for giving SWIT the pride of place we now enjoy through consistent all-round support. Just this year, we have received huge amounts from our parent body to support our activities and last month, in an effort to pursue improved female gender inclusiveness in CITN policies, the President and Chairman of Council passed a directive that all State District chairmen should ensure the establishment and smooth functioning of SWIT in their respective states. This definitely will improve SWIT's visibility and impact nationally. On our part, we pledge our hallmark of commitment to service, loyalty and diligence to CITN. ### SWIT AND NATIONAL DEVELOPMENT

The developments in the global space have shown that across the world, taxation is now the "big elephant in the room" which governments across the globe collect to collect their fair share of income emanating from their respective jurisdictions. Also, the awakening of the annual Finance Act cycle to support the Appropriation Act and make amendments to the tax laws, passage of The Finance Acts 2019 and 2020; automation of tax administration and investment in technology embarked upon by the Federal Inland Revenue Service (FIRS) and most of the States Internal Revenue Services; passage of the Petroleum Industry Bill (PIB) 2020 by the Senate on 1 July 2021, are germane issues at the front burner.

The recent decision of the G7 countries to impose "global minimum tax" on multinationals that operate across their jurisdictions has shown clearly that taxation has become a main source of revenue generation globally. The decision is not unconnected with the Base Erosion and Profit Shifting (BEPS) project championed by the Organization for Economic Cooperation and Development (OECD). Considering that the world is a global village, there is no doubt that the happenings in the international tax environment will not filter down to our local tax community and therefore, there is need for our women to be kept abreast of these developments. During my term of office by God's grace, we shall leverage on our mother Institute's membership of the Global Tax Advisers Platform (GTAP) through the West African Union of Tax Institutes (WAUTI) to connect with women in other climes for dialogue on international tax matters.

As the global tax environment is blocking tax leakages from their jurisdictions, Nigeria's tax system is also undergoing significant improvement to achieve the same objective. This has been demonstrated with awakening of the annual Finance Act cycle to support the Appropriation Act and make amendments to the tax laws. The Finance Acts 2019 and 2020 changed the face of the Nigerian tax system as provisions in the tax laws that are reviewed to align with the government's ease of doing business objective and expand the tax base in order to bring more taxpayers into the net. Furthermore, the automation of tax administration and investment in technology embarked upon by the Federal Inland Revenue Service (FIRS) and most of the States Internal Revenue Services are coming at the right time when the impact of COVID-19 pandemic has resulted into change in business models from the conventional



approach to being technology-driven. There is no doubt that this will position the revenue authorities rightly for capturing the digital economy to harness the tax revenue potential locked up in transactions conducted by non-residents doing business with and in Nigeria. The Society of Women in Taxation under my watch will continue to support government's initiatives on improving the tax system by organizing forums and encouraging our women to tell the taxation story to women-fold, most especially our women in other professional bodies, women executives and women-preneurs.

I would not have done justice to developments in Nigeria's tax environment without talking about the great achievement of passing the Petroleum Industry Bill (PIB) 2020 by the Senate on 1 July 2021 after over a decade of making attempt to amend the various Acts guiding the regulation and operation of the oil and gas industry. We are hopeful that the PIB will lead to a massive transformation of the industry and succeed in attracting the desired investment required to reposition the industry. It is our expectation that the provisions of the PIB will be enough to stimulate the desired investment and in future be further reviewed to address the issue of energy transition from fossil fuel to clean energy. We look forward to the passage of the PIB into law, as I shall be working with my fellow women in taxation to explore the provisions of the Bill towards the technical development of our women, most especially for the benefit of our members in the industry.

### **SWIT'S PROGRAMS/PROJECTS**

By the grace of God, SWIT will act as an interface between the government and the governed through advocacy and sensitization activities to educate the public on the types of taxes to be paid and how to pay rightly devoid of double taxation; while at the same time ensure that such advocacy events lead to more revenue generation for the government at different levels and performance of the attached responsibilities.

Professional women, market women and artisans will be our main focus, while tax education through school debates will form a centre stage. We hope to make this information available to the public through SWIT quarterly Bulletin. We must not forget that the two in one Associations- Chartered Institute of Taxation of Nigeria (CITN) which is the umbrella body of Society of Women in Taxation (SWIT) are unique and special in all their objectives and activities, in that both work to support the government, not only to improve internally generated revenue, but particularly to enlighten the public on the importance of their civic roles, that will make people pay with good understanding and less stress for the government. This is why the government at all levels should realise these unique responsibilities and support these two Associations in their programmes and projects.

With the present situation of dwindling income from the oil sector and the struggles of the Agricultural sector to feed the nation and earn income for the nation, internally generated revenue through taxation presents a viable source of income for the government and that is why the CITN and SWIT should be adequately supported to propagate the tax message.

## SWIT AND CHANGE MANAGEMENT PLANS OF FIRS

A change is the project, initiative or solution being introduced in the organization to improve the way work gets done, solve a problem, or take advantage of an opportunity; while change management plan is the application of a structured process and set of tools for leading the people side of change to achieve a desired outcome (Prosci, 2021).



The effects of COVID-19 pandemic scenario on the Nigerian tax system cannot be overemphasised. The Pandemic has impacted Nigeria's budget by reducing tax receipts and increasing spending on programs to save lives. Also, medium- and small-scale entrepreneurs and blue-chip companies were affected. On its part, the Federal Inland Revenue Service introduced tax relief measures to mitigate the effects of the pandemic on taxpayers. In line with the above, the leadership of FIRS has introduced some initiatives to improve tax administration in Nigeria, viz: E-Filling, TaxPro Max and Auto Vat Collection. FIRS launched the TaxPro Max online returns filing and payments system to improve on the current collection methods and level of compliance from taxpayers all over the country in order to; provide a seamless returns filing and payment system which is permanently accessible to everyone 24/7 no matter the location, reduce the taxpayer's physical contact with the tax office, improve the record keeping system for both FIRS and taxpayers for future reference, and to improve transparency among others. Thus, in furtherance of SWIT's existing partnership with FIRS we plan to sensitise the nation at national and state levels to make people familiar with these new terms and how it can help easy tax processes.

### STATE OF THE NATION

SWIT is concerned about the current rate of insecurity in the country. The activities of bandits and kidnappers have made our roads unsafe. School campuses at basic, secondary and tertiary levels that used to be the safest to keep our children has turned to the den of unsafety, disappearance and murdering of our children. Villages that enjoy calmness and peace through farming and handiwork are attacked and massacred in their homes without any ammunition to fight back.

Members of the Armed Forces defending the integrity of our nation are attacked and killed in the face of superior ammunitions from unlawful attackers, herders and farmers who used to be good neighbours benefitting from each other's products have become enemies, youth corps members select states that are safe for them to serve the nation, the standard of education is falling because of dearth of government investment in the education sector, these and many others have given rise to ceassionist agitations, floating of regional security outfits now competing with national security sector, among several other security challenges. We therefore call on the government at all levels to address these worrisome issues that have placed Nigeria in the negative focus of the international community.


